Hi. We have 3 kids in the schools. What if one is displaying these symptoms? Do they all have to stay home? Looking for clarification.	<p>Great question.</p> <p>Here's what the Indiana State Department of Health says:</p> <p>So according to that guidance, the questions are:</p> <ol style="list-style-type: none"> <li>1. Has your child who is experiencing symptoms been isolated from all other family members?</li> <li>2. If the child who has symptoms has been isolated, and the other children have not been near the child with symptoms, then they can continue to go to school.</li> <li>3. If your family has not been able to isolate the child with symptoms, then your family should all quarantine (and not attend school).</li> </ol> <p>Obviously, you will want to consult your child's pediatrician for their guidance on next steps.</p>

Indiana State Department of Health Screening Guidance	The Indiana State Department of Health has provided guidance for screening each day for staff and students. Here is our new screening process that is to be completed by each staff member and each student prior to coming to school:

**Every morning before you send your child to school please check the following:**

**1** Your student does **NOT** have a fever greater than 100.4 degrees *(may be lower based on your school's policy)* OR lower if your child is not feeling well.

**➔** If the answer is **YES** to any of the questions, **DO NOT** send your student to school. Instead, begin quarantine of your child and contact your healthcare provider. Strongly consider COVID-19 testing.

Documentation from Individual's Doctor	If you have a pre-existing medical condition (like asthma, headaches) that may mimic the symptoms of illness but be otherwise explained, please make sure you have documentation on file with the nurse at school from your provider that states the diagnosis and symptoms that are experienced. This will help us as we navigate this year.																						
Meals Available for Students Participating in eLearning	Meal pickup will be available. The parent will preorder 5 breakfast and 5 lunches for a once a week pickup. These meals will be charged to the students lunch account according to their																						

	Free/Reduced/Full Pay status. More information will be coming to families of eLearning students.
One Thing I've Learned...	<p>We can put all these things in place in our plan.</p> <p>We can do our part to protect each Wolf and the Pack when we come to school.</p> <p>But if we are not doing our part in our lives outside of school (washing our hands, social distancing, wearing masks), it will be a challenge to remain on green with brick and mortar learning and maintain a vibrant economy. We are in this together!</p>
Questions Added after July 6, 2020	
In the green, traditional phase, when exactly will students need to wear masks?	<p>The general answer is that students will wear a mask when social distancing is not possible. The health department has helped us define this as well, including when they think it's OK to take off a mask.</p> <p>Let's try walking through a typical school day:</p> <ul style="list-style-type: none"> <li>• Students get on the bus: wear a mask</li> <li>• Students are dropped off at school: wear a mask</li> <li>• Students walk through halls: wear a mask</li> <li>• Students outside at PE: may not need to wear a mask (this assumes there is some distance between them)</li> <li>• Students outside at recess: may not need to wear a mask (this assumes there is some distance between them)</li> <li>• Students seated, facing forward in the classroom learning: do not need to wear a mask</li> <li>• Students working with teacher in the classroom: wear a mask</li> <li>• Students working in small groups in the classroom: wear a mask</li> <li>• Students engaged in active participation activity (or lab) in the classroom: wear a mask</li> <li>• Students in line to get lunch: wear a mask</li> <li>• Students eating lunch: do not wear a mask</li> <li>• Students head home on bus: wear a mask</li> <li>• Students head out to be picked up: wear a mask</li> </ul>
Will students would all be required to face the same direction and not facing each other to help minimize spread since they obviously can't wear masks when eating?	It depends on the location and the table design at the building. Each administrator is working to design cafeteria seating. (Many of the tables are round)

Transportation: Can I switch to a bus after a couple of weeks?	The choice to either transport or ride the bus is made by semester. As we are scheduling routes and making seating charts, it will be difficult to make constant changes to these.
Can friends ride the bus home with my child?	No. As we are needing to keep a seating chart on the bus and will use that to spread students out as much as possible, we cannot accommodate additional students on the bus.
Can middle school students ride home on the elementary bus?	No. As we are needing to keep a seating chart on the bus and will use that to spread students out as much as possible, we cannot accommodate additional students on the bus.
Can elementary school students ride to school on the middle school bus?	No. As we are needing to keep a seating chart on the bus and will use that to spread students out as much as possible, we cannot accommodate additional students on the bus.
Will there still be an SRO at the Complex and an SRO at BGHS (that also goes to PLE)?	Yes! We will maintain our SRO presence in our schools and believe this is vital to school safety!
Is it a good idea to begin to have my child practice wearing a mask?	Absolutely! The more you can practice this now the easier it will be for your child when school starts. The more you make this a normal, accepted practice (like wearing a seatbelt), the more your children will understand this is part of life right now. All PTSC Schools	
Can students bring textbooks back and forth from school?	Yes.
Who will provide masks to students and staff? Will we be required to purchase/make our own?	Students will receive 3 masks through a student fee. Additionally, Governor Holcomb is providing one mask for each student. This mask is free of charge and will be kept at school should your child need to change a mask during the day (and then sent home for you to launder). Staff will receive a mask through PTSC.
How will students check out books in all 4 schools?	Library time and library books will still be available for checkout. According to CDC library best practices, the virus does not live on paper for longer than 24 hours. Returned books may sit for a day before being checked in and returned to circulation.
When would parents know what schedule their child is on for Plan B? How will that be determined per classroom?	As soon as the decision is made that we must move to plan B, schedules will be made. We will work to keep families on the same schedule and from there balance numbers in each classroom. As soon as we can assign all families to a schedule, we will communicate that to parents so they have as much time as possible to prepare.



Should the waivers be suspended until further notice to encourage ill students to stay home? What about attendance and punitive measures?	Student handbooks will be revised regarding attendance. Punitive measures for excused absences will be removed along with attendance incentive programs that may encourage a student to attend school if they are experiencing any symptoms of COVID-19.
How will we monitor subs before they come into the building?	Substitute teachers will be required to follow the self-screening procedures set forth in the PTSC Return to Learn Plan prior to entering a building.
Will there still be KidStop?	Yes, this will run just as it has in the past with their own precautions in place as structured by the Boys and Girls Club.
How will lunch be handled? Will they have to sit 6 feet apart?	In our cafeteria spaces we are working to provide expanded eating areas, additional tables, seating charts, and alternative eating areas. We will space students out to the best of our ability. We will make sure students have time to eat.
My child is in the special needs class. Will they have a different protocol? Also how would this work for children who are unable to understand fully and vocalize their symptoms?	Special education teachers will be providing the same services as other teachers. If we are in red and students cannot be in the building, they will have access to the teacher and instruction in a virtual classroom. The school setting may change, but the student will have instruction as he/she would have if in the building. Virtual speech and related services are also available. Additional needs should be addressed with the special education teacher and also can be addressed through a case conference as needed.
While this is not a health concern, is there an additional drop off plan in the mornings with more kids likely being brought to school by parents with long drop off lines.	Our buildings are going to be flexible with families that are transporting students to multiple buildings. Please communicate as needed with the building principal. There may be new procedures (especially at the Complex we are changing things to accommodate additional drop offs and pickups). Additionally, we will be flexible as we know that students may be arriving late due to the logistics of dropping off. Please work with your building administrator and they are ready to work with you. Tardies due to this new drop off scenario will not be penalized.
Will the class sizes be the same?	That will depend on how many students are online and how many are traditional. We have not reduced staffing, like other corporations anticipating a drop in funding for the next budget year. Thankfully our funding will hold this fall, but we anticipate a cut for our next budget.
Are masks going to be required in the school settings?	Please see the plan. At green, masks are required when social distancing cannot be maintained. At yellow, masks are required.
We have a wedding out of town in September. Will there be protocols in place for traveling? More specifically, if my daughter goes with, will she need to quarantine before returning to in	At this time we have not developed these, but it may be coming. Some states are requiring residents to quarantine at home after traveling to certain states.

class instruction?	
What are cohort groups?	In K-5, a cohort group is your class. So if you are in Mrs. Rippe's class, that is your cohort group. In 6-8, we are working to keep cohort groups as much as possible as in K-5. There might be students that have to change groups. Cohort groups are essential for contact tracing. It is extremely challenging to cohort group at the high school level, and why students will still rotate to the individual schedule of classes for that student.
Will kids be given "hand-washing breaks" from the teacher? Will the teachers enforce this?	Handwashing will be essential and stressed. Additionally, hand sanitizer will be provided throughout the building. Students who are old enough to manage hand sanitizer are welcome to bring a personal size one for their pocket if the parent so chooses.
It says they prefer online payment for lunch accounts to avoid contact. Will they be waiving the additional processing fee for online payments then?	Unfortunately we do not have a funding stream to cover those fees.
Should students wear masks while entering the building in the morning after being dropped off by parents or the bus until they arrive at the classroom?	Yes. On the green traditional schedule, masks are to be worn when social distancing cannot be maintained. (Yellow masks are always required)
Is it possible to enroll one child in eLearning while keeping another child in traditional? How do I go about doing so?	Yes. When you register you will select a pathway for each child. Registration starts Monday, July 13, 2020.
How will the seating be on the bus?	Students will be assigned seats. Siblings will sit together. We will spread students out the best we can. This is why we are recommending you to transport your students. At registration you will select if you are going to transport or need bus transportation. If you need bus transportation one way, please select that you need bus transportation as your child will be assigned a seat.
If a child is unwilling or having a hard time with a mask, what will happen?	We will provide mask education, including the right way to put on the mask and take off the mask. A great way to help your child is to start practicing now. Make this normal for them, just like wearing a seatbelt. Then when they arrive at school, this will just be part of life together when social distancing cannot be maintained.
What will this do to absenteeism rates?	The state knows that we will experience increased rates of student absence this year. That will mean parents are doing what is needed to protect all students. Our handbook is also being



	modified to reflect this. The Indiana State Department of Health (ISDH) tracks COVID cases. The Porter County Department of Health will also be working closely with us.
Would the registration be done online?	Yes. Registration opens online July 13, 2020. Watch for information from your school.
If we pick elearning are our kids still able to participate in sports?	At this time, yes. We take our guidance from the IDOE and IHSAA.
How can you space kids out in a classroom if there are over 25 kids in each class?	According to the Health Department, we are to space them to the best of our ability.
It's still early in the summer. Indiana isn't fully open until July 4th. What prompted this early decision to re-enter on green and is it possible this may change before school starts?	Parents communicated to us that the sooner we communicate the plan to them the better as many parents have many plans to put in place to accommodate our plan. We are monitoring COVID levels and will adjust the plan as needed.
Locker use - is it going to be allowed? How do the students practice social distancing when using locker?	At BGHS, lockers are available upon request. At BGMS, they are still evaluating the plan. BGHS students will be allowed to utilize a backpack if needed.
If students do not ride a bus to school, are they allowed to ride home or to BGHS for a sport practice/game?	If you need bus transportation to or from school, you need to select that at registration. Sporting transportation is separate from transportation to and from school.
Will someone be sanitizing/cleaning high traffic areas while school is in session?	Yes.
Will there still be band concerts?	A decision has not yet been made. Likely any performances will be recorded. More information will come in the future.
I read that the desks will be cleaned and sanitized while the students switch from class to class, who is responsible for that?	Each teacher will develop a process for this. Likely each student will use a wipe or a paper towel. The chemicals used are what the Indiana State Department of Health has said is a viable practice for completing this task by student or teacher.

If your child is absent due to illness of any kind, tuition is still collected just as always.

<p>How will absences be tracked?</p>	<p>PTSC has developed a new absence form for all parents to use. The Indiana State Department of Health will lead contact tracing and investigation efforts in consultation with the local health department to ensure that close contacts are identified quickly. The local health department can confirm the lab result.</p>
<p>From ISDH: Who is responsible for letting people know that they are considered a close contact and need to self-quarantine for 14 days?</p> <p><a href="#">COVID-19 Planning for Schools and Local Health Departments: Frequently Asked Questions Role of nurses: Role of Local Health Depa</a></p>	<p>The Indiana State Department of Health will lead contact tracing and case investigation in consultation with the local health department. This is why it's critical that schools immediately contact their local health department upon learning of a positive COVID case among the student body or staff.</p>

For example, if they need to provide information to help with contract tracing, such as talking to the teacher to see what other students might be a close contact, they can share the ill student's name. Schools would be urged to fully cooperate in contact tracing to mitigate the risk of exposure. The minimum amount of information necessary should be shared; for instance, if an entire class were to be considered a close contact, the local health department may only need to indicate the class, not a specific student. Under these circumstances the other parents will be informed that their child has been deemed a close contact of someone in their class without naming the child directly. Many students and family will figure out who the positive individual is, but the school would not be encouraged to provide that information.</p>

<p>From ISDH: If we are unable to social distance with 6 feet between desks in classrooms, but all students are facing the same direction, can students not wear masks except during movement?</p> <p><a href="#">COVID-19 Planning for Schools and Local Health Departments: Frequently Asked Questions Role of nurses: Role of Local Health Depa</a></p>	<p>We encourage the use of masks and highly recommend that students remain 6 feet apart. However, we recognize that it may not be possible in some classrooms. In addition, younger students especially may need to have a break from their masks. This would be the most acceptable time or situation for them to remove them unless they were outside, which is even better</p>
<p>From ISDH: Does the state recommend staff and students be tested regularly?</p> <p><a href="#">COVID-19 Planning for Schools and Local Health Departments: Frequently Asked Questions Role of nurses: Role of Local Health Depa</a></p>	<p>We do NOT recommend regular testing, because it's just a snapshot in time. You can test negative today and be positive tomorrow. We do recommend that all students and school employees be educated about the symptoms of COVID-19 before school starts, and that they self-screen for symptoms each day before coming to school. We also recommend that schools know of testing sites in the area to refer students and staff.</p>

to complete absent days with Elearning?	
Will children visibly showing signs of sickness whatever the illness may be, be sent home? Uncontrollable cough, constant sneezing, blowing nose etc?	Yes. We have the right to exclude children from school.
What about kids with asthma and having to wear a mask?	Please work with your medical provider. If they determine a face mask cannot be worn by your child and instead your child should wear a face shield, they will provide documentation so we can make that accommodation due to your child's specific health needs.
Let's pretend a student has symptoms of COVID-19 and is staying home. Some testing centers have taken 3 days or more to make an appointment for testing. Then up to 5 days for results. A student with COVID-19 may miss 2 weeks of school or more. What is the plan to help students stay on track with their education? E-learning? Or parents to pick up assignments?	eLearning will be available for students who are absent.
If I have more than one child and one of them has symptoms of COVID-19, do they all need to stay home?	Please see the Return to Learn Plan for specifics regarding someone in your home having symptoms of COVID.
What if you suspect a child has COVID, but the parents opt to not have them tested? Who decides then on when that child should return?	Please see the plan for specifics on when students may return without a COVID test. COVID testing, if negative, will allow students to return much sooner.
eLearning	
If a parent feels that their child is not safe during "sick times" in the building (high incidents of flu/colds), can they opt to change to elearning until they feel the building is safer and then let their child come back?	<p>eLearning is not an in and out option as we are making staffing decisions based on enrollment.</p> <p>eLearning will be offered as a pathway all school year.</p> <p>eLearning can be chosen in semester increments.</p> <p>If you start out as traditional, it is an option to move to eLearning for the rest of the semester.</p>

	If you start out eLearning or switch to eLearning, you will need to complete the semester in eLearning.
My question is, will virtual learning include being logged in and with a live teacher all day or is it more like one hour each day? If it's not daily, will it only be a couple of days of virtual meetings? Will assignments need to be completed each day or will they have the week to finish everything?	eLearning will be specific to each teacher. One day there may be a live instructional session where you join the class at a specific time. Another day the instruction from the teacher may be recorded. Please note that access to the teacher and all live sessions will be during the school day online. Recordings of those sessions may be provided for additional or later viewing. Each teacher will determine when assignments are due as some may be projects that take longer and others may be an assignment for the day. The goal is that this is like participating in class, only at home.
I would like to know more regarding the meetings (will they be required to attend meetings daily for each class), will they need to be checked in for a certain length of time or is it just to do the assignments and then they will be done? Will there be additional work (i.e. homework).	All eLearning sessions are required, although there may be an opportunity to watch a recording at a later time. It is not an option to not attend. This is not just the posting of assignments online, this is instruction from a teacher. Yes, there will be homework, just as a traditional classroom.
What is the deadline to choose e-learning?	You will chose at registration on July 13, 2020.
What is the district doing to ensure students are receiving appropriate grade-level instruction through e-learning that is consistent with the classroom?	We are making improvements to our eLearning program as we shift to extended eLearning. This is why we are providing instruction from a teacher that is what is being taught in class.
What is the target amount of time students should be spending completing e-learning each day?	eLearning times should mirror an instructional day. Of course the time it takes to complete work varies from student to student, so it will take some students more time than others just as it does in the classroom and at home.
How are the teachers working together to make e-learning as hands-on and engaging as brick and mortar instruction? Will teachers be doubling both e-learning and in-class instruction or will there be a designated e-learning teacher?	We are making decisions on our eLearning teachers after we receive our registration data.
With the elearning option, will there be extended deadlines for children, like midnight or the following day at noon, like we did last year?	Each teacher will set timelines for dates due. It is reasonable to expect that work for eLearning will be due the next day, unless it is a larger project.

When we have a suspected/confirmed case	
If the school moves to red would it try to reopen? And if so, would it reopen back to yellow or green?	That decision will be made with the Porter County Health Department. Likely we will reopen on green. If the decision is made to move to yellow, it will be the model we use for an extended period of time.
If a student/staff is sent home from school with symptoms, how will the rest of the school day be handled? How do we clean where the child/staff has been before anyone else is exposed in the middle of the day?	Cleaning will be happening throughout the school day, every day.  If we have a suspected case of COVID, and emergency cleaning may happen in those spaces prior to the end of the day.
If a student tests positive will the school be closed immediately?	Not necessarily. This decision will be made with the Porter County Health Department and depends heavily on how the student was cohorted and how contact tracing can be completed. It may be that some children are asked to stay home, a classroom, a grade level, one building, or perhaps the district. This will be a case by case decision.
Dr. Schmidt mentioned that we may have to go to yellow or red depending upon cases in our area and if there is transmission inside the schools. Can I get clarification on that? How will the school determine if students have passed it directly to each other?	A decision to move to yellow will be made with the Porter County Health Department based on their knowledge and data.  Seating charts are kept and the Indiana State Department of Health has defined what a close contact is for contract tracing and who needs to quarantine (15 minutes of sustained contact in less than 6 feet)
How many cases must be reported for the school to move from green to yellow or yellow to red? Is it just countywide cases or cases in our district?	This is not a formula and there is no magic number. This will be based on Porter Township data. (At least that's the plan at this moment!)

Another way to think about it...



10 days

- Student gets tested for COVID-19 at a testing event put on by a community organization. The student was symptom-free when he got the test. The test comes back positive. The student must *isolate* and stay symptom-free for 10 days after the date he took the test.



14 days

- Student gets tested for COVID-19 at a testing event put on by a community organization. The student was symptom-free when she got the test. The test comes back positive. The student starts *isolating* for 10 days after the date she took the test. Four days into her *isolation*, she develops a fever and cough. She must now *isolate* at home for at least 10 days and 72 hours fever-free without fever-reducing medicine and with improvement in respiratory symptoms. The student ends up *isolating* at home for 14 days.



14 days

- Student tests positive and has three siblings in the home or as close contacts who attend other schools. If the siblings have symptoms, they should be tested and report to that school if results are positive. Otherwise, siblings should *quarantine* for 14 days before returning to school. Contacts of the siblings are not considered a close contact unless the siblings test positive themselves.



10 days  
72 hours

- Student has a fever, cough, headache and loss of taste and smell. The student goes to get tested and the test is negative. There is at least a 30% chance of having a false negative test. Therefore, it would still be required that this student *isolate* at home for at least 10 days and 72 hours fever-free without medication and with reduction in respiratory symptoms.



24 hours

- Student has a fever and sore throat and history of getting strep throat. Student sees her provider, who does a strep test and exam and believes the patient has strep throat and does not have COVID-19. The student may return to school after 24 hours fever-free with a note from her provider stating she may return to school.



10 days  
72 hours

- Student has fever, cough, shortness or breath, and loss of taste and smell. His parents do not want to get him tested for COVID-19. Highly recommend that the student get tested so that the proper contact tracing can be done. The student will need to *isolate* at home for at least 10 days and go 72 hours fever-free without use of medication and have a reduction in respiratory symptoms. Additionally, if the school is suspicious that the student has COVID-19, the school could do contact tracing and monitoring for others with symptoms..
