Mrs. Harlow made a motion to approve the consent agenda consisting of payroll claims and accounts payable vouchers; approval of the minutes of the Regular School Board Meeting held on Thursday, October 8, 2020 at 6:30 p.m. and approval of the items listed on the Personnel Report pending clear background searches and waiving the readings as recommended by Dr. Schmidt; seconded by Mrs. Sgouros. Motion carried 3-0.

Mrs. Smith referred to the appropriation summary and the fund report provided in the board packet and asked for questions from the board; no questions were heard.

#### 5. BUSINESS

## A. Approve Collective Bargaining Agreement - Dr. Schmidt

Dr. Schmidt said that the tentative Collective Bargaining Agreement was discussed at the last board meeting reflecting an unchanged beginning base salary of \$40,000 with no compensation increases for the 2020-2021 school year. There is also additional language regarding the addition of COVID-19 built-in days available for the 2020-2021 school year only. Dr. Schmidt opened the meeting for public comment and heard no requests for public comment. Mrs. Sgouros made a motion to approve the Collective Bargaining Agreement as presented in the board packet and recommended by Dr. Schmidt; seconded by Mrs. Harlow. Motion carried 3-0.

## B. Approve Administrative Contract Extensions - Dr. Schmidt

Dr. Schmidt recommended administrative contract extensions for an additional year with no compensation increases as provided in the board packet. Additionally, Dr. Schmidt recommended a contract extension until June 30, 2022 for Kathleen Smith with a salary of \$74,000 and a title change to the Chief Financial Officer. Dr. Schmidt said Mrs. Smith has done a fantastic job bringing her expertise into her new role and making this office her own. Mrs. Harlow made a motion to approve the administrative contract extensions and a contract extension until June 30, 2022 for Kathleen Smith with a salary of \$74,000 and a title change to Chief Financial Officer as recommended by Dr. Schmidt and as provided in the board packet; seconded by Mrs. Sgouros. Motion carried 3-0.

## C. Approve Digital Tickets Sales Contract - Dr. Schmidt

Dr. Schmidt said after hearing the Governor's press conference this week and reports of our county fluctuating between orange and red category right now, there is a possibility of a restriction of only allowing parents to attend athletic events. There is also a need to provide a way to sell tickets contactless and digitally to parents. Dr. Schmidt recommended approval of the digital ticket sales contract provided in the board packet which is at no cost to the district; however, there is a \$1 per ticket upcharge to the parents. Dr. Schmidt also noted that currently our ticket prices are a bit lower than other conference ticket prices. Mrs. Sgouros made a motion to approve the digital tickets sales contract as provided in the board packet and recommended by Dr. Schmidt; seconded by Mrs. Harlow. Motion carried 3-0.

## D. Accept Donations - Dr. Schmidt

Dr. Schmidt recommended acceptance of a generous donation in the amount of \$250 for the high school cheerleaders and \$250 for the middle school cheerleaders from one of our families. Mrs. Sgouros made a motion to accept the generous donation in the amount of \$250 for the high school cheerleaders and \$250 for the middle school cheerleaders. Motion carried 3-0.

## E. Accept Transfer Students - Dr. Schmidt

Dr. Schmidt recommended acceptance of a transfer student in Kindergarten and a transfer student in Grade 10 for the 2020-2021 school year noting that both students have met all requirements and are in good standing. Mrs. Harlow made a motion to accept the transfer students as recommended by Dr. Schmidt and presented in the board packet; seconded by Mrs. Sgouros. Motion carried 3-0.

## F. Approve Fundraisers - Dr. Schmidt

Dr. Schmidt recommended approval of three fundraisers as presented in the board packet for National Honor Society, the Class of 2021 and the Boone Grove Baseball Team. Mrs. Sgouros made a motion to approve the fundraisers as recommended by Dr. Schmidt for National Honor Society, the Class of 2021 and the Boone Grove Baseball Team; seconded by Mrs. Harlow. Motion carried 3-0.

#### G. Other - Dr. Schmidt

Dr. Schmidt announced two "Other" items will be presented by Mrs. Smith and Mr. Parrish

# G1. Other - Adopt Resolution #1120-235 - Appropriation Reduction Resolution - Mrs. Smith

Mrs. Smith recommended adoption of Resolution #1120-235-Appropriation Reduction Resolution to reflect a reduction of encumbrances due to cancelled or reduced purchase orders due to COVID-19 or reduction in Capital Projects as provided in the board packet. Mrs. Harlow made a motion to adopt Resolution #1120-235-Appropriation Reduction Resolution as recommended by Mrs. Smith; seconded by Mrs. Sgouros. Motion carried 3-0.

## G2. Other - Approval of COVID Days for Classified Staff - Mr. Parrish

Mr. Parrish recommended approval of the addition of ten (10) COVID-19 Days built in for Classified Staff similar to the COVID-19 days built in for the teaching staff in the Collective Bargaining Agreement. The employee must be in good standing, must have exhausted all of the emergency paid sick leave through the FFCRA, must complete a supporting documentation form and meet qualifying reasons related to COVID 19 to be allowed to use these days. The pay rate will be provided at the employee's normal daily rate. As per the Collective Bargaining Agreement, these ten (10) COVID-19 days will expire on the last teacher day on May 26, 2021. For Classified Staff the ten (10) COVID-19 days will expire on June 30, 2021. Mr. Parrish also noted that unused COVID-19 days will not accumulate or carry over for any employee. Mrs. Harlow made a motion to approve the addition of ten (10) COVID-19 Days built in for the Classified Staff as recommended by Mr. Parrish; seconded by Mrs. Sgouros. Motion carried 3-0.

## 6. ASSISTANT SUPERINTENDENT REPORT – Mr. Parrish

#### Personnel Profile:

Mr. Parrish announced Carrie Rippe as the Personnel Profile for tonight. Mrs. Rippe is a 4th grade teacher at Boone Grove Elementary School with 22 years of service. Mrs. Rippe is a graduate of Valparaiso University. Mr. Ivanyo said, "Mrs. Rippe is a dedicated educator who finds ways to reach every student in any type of situation and adversity. She is able to adapt what she does in the classroom to fit the needs of her kids and provides each student a path to succeed." Mr. Parrish said, "Mrs. Rippe is a rock solid teacher and person. PTSC is very fortunate to have Mrs. Rippe as a member of our staff as she always does a fantastic job."

## **School Announcements:**

BGHS: Mr. Corman gave a shout out to his amazing support staff. BGHS has been working short-staffed and the secretaries, counselors, nurses and SROs have all stepped up to help selflessly to set a positive tone in the building every single day. The teachers are incredible and have devoted an awesome amount of time, care and effort working during this difficult time. Mr. Parrish said this sentiment can be echoed in every school building. Also, Mrs. Georgian was selected by the students as the Teacher of the Month at BGHS.

PLE: PLE had a really good turnout for Parent/Teacher Conferences with a 96.4% attendance rate! The Thanksgiving Holiday Food Drive for the Hebron Food Pantry is next week and they also hope to conduct the annual pie throw virtually this year.

BGE: Monday is the virtual Spell Bowl which will be ran by BGE Sponsors, Mrs. Hurley and Mrs. Peterson.

#### 7. SUPERINTENDENT REPORT - Dr. Schmidt

Dr. Schmidt explained that past practice has been to award service pins and certificates to all employees who have achieved 5 years of service at every 5-year increment. Additionally, beginning with this year, award clocks were awarded to employees who have achieved 25 years of service or more at 5-year increments. Dr. Schmidt shared an I-Movie honoring employees who received award clocks and the recipients were: for 25 Years of Service: Clay Corman, BGHS Principal; Janell Stone, BGHS Guidance Secretary and Terrell White, Cafeteria Worker at the Boone Grove Complex and for 30 Years of Service: Linda Bult, Deputy Treasurer at PTSC Administration Building.

Update on COVID — Dr. Schmidt reported that the positivity rating indicates Porter County is currently in the orange category and with the rising numbers will likely move to the red category this week. We now have 12 active positive cases with 66 quarantined as a result of these 12 active positive cases. Dr. Schmidt said she made a video today to try to share information in a different way with the parents. If we move to the red category, we are advised not to hold indoor special season events and athletic events should be limited to athletes and parents only requiring masks at all times. Dr. Schmidt said staffing our buildings due to a substitute teacher shortage is becoming challenging and discussed ways this issue is being handled. Dr. Schmidt also noted that the staff is exhausted, stressed and overwhelmed. If a school or schools shift to virtual learning, teachers will be zooming from their classrooms each period for grades 6-12 or in subject block chunks Grades PK-5; teachers will be in their classroom and meeting students virtually each period; students will be turning in work online; teachers will be responding to work online; teachers and students will be messaging through Schoology and/or meeting in small groups via Zoom as needed for five days per week of instruction at two week increments. Dr. Schmidt answered questions from the board.
