#### A. School Announcements - Mr. Parrish

Mr. Parrish reported on the following:

- BGHS did a fantastic job handling a two-hour power outage today. BGHS held their first blended Wednesday yesterday and the Principal Counsel hosted a Meet and Greet today for new students.
- BGMS sports have begun. BGMS Picture day is August 25. A special speaker, Nathan Harmon of Your Life Speaks, will be at BGMS on the 25th. NWEA testing starts in the next few weeks.
- BGE has had a fantastic start to the year and staff has been very welcoming for new staff. BGE Picture
  Day is on August 2 h.
- PLE had 88.6% attendance rate during their Open House last week. PLE Construction Update: Paving is starting on Monday on the Preschool driver line and hopefully will begin work on playground at the end of next week
- We started the year with the Continue to Learn Plan currently have one positive case and no kids are currently quarantined. We will continue to follow the Continue to Learn Plan and will constantly continue to evaluate numbers and discussions for changes to ensure the safety of staff and students.

# A. Report to the Board on the S.E.A. 390 Public Hearing of the Association of Porter Township Educators and Porter Township School Corporation

Mr. Parrish reported that a S.E.A. 390 Public Hearing of the Association of Porter Township Educators and Porter Township School Corporation was held on August 4, 2021 at 3:15 p.m. at the Porter Township School Corporation Administration Building in the Board Room to receive public testimony regarding teacher compensation and collective bargaining. Mr. Parrish reported that there was no public participation during the hearing. Mr. Parrish also reported on the following:

- A Summer Feeding Report was provided reporting each week during the summer reflected a total of 29.212 total meals handed out during the summer, which is fantastic!
- As of August 18, this year's student total enrollment is 1390 for in-person enrollment, 32 for virtual enrollment; totaling 1432; Mr. Parrish said last year's total enrollment was 1371. Additionally, Mr. Parrish noted that the 32 virtual students will receive 85% of ADM funding instead of full funding.
- Review of Grants: Esser I Grants \$86,929.00: Required distribution of approximately \$4,300 to non-pubs and the remainder was used for our floating subs and instructional aides in each building.
- Esser II Grants \$338,000; budgeted \$314,000 currently. Funds were used for COVID expenses, floating subs, stipends for teachers, principals, and non-certified staff
- Esser III \$760.000.00: \$692,000 was budgeted and \$252,000 was used toward learning loss, to purchase new English and Math textbooks at BGE, to purchase a remediation and enrichment tool to be used for K-8 to tie into NWEA to pull data to help address deficiencies, and also to buy tables for lunchroom seating in the cafeteria to help keep kids socially distanced.
- Mr. Parrish wished a Happy Birthday to the following who have upcoming Birthdays: Jamie Smec, Christina Kegebein, Josh Russell and Jim Rosinia.
