- 1. CALL TO ORDER Dr. Natalie Wargo, President 6:39 p.m.
 - A. Pledge of Allegiance
 - B. Welcome Visitors

Board members present were: Dr. Natalie Wargo, Mrs. Laura Chavez, Mrs. Mary Harlow and Mrs. Lilann Sgouros; Ms. Johanna Williams was absent. Also present were: Superintendent, Dr. Stacey Schmidt; Assistant Superintendent, Mr. Ben Parrish; Board Attorney, Cheryl Zic; CFO Treasurer, Kathleen Smith and Deputy Treasurer, Linda Bult. There were 69 present in the audience.

2. AGENDA ADJUSTMENTS - Dr. Schmidt

Dr. Schmidt announced removal of two of the following advertised public hearings on the agenda due to the change in the advertised location of the meeting:

- Removal of Agenda Item 4. Public Hearing on BGHS Waste Water Treatment Plant Improvements
- Removal of Agenda Business Item 7A. Public Hearing of 2022 Budget
- Dr. Schmidt also added an Agenda Item: COVID Update immediately following Public Participation.

3. PUBLIC PARTICIPATION - AGENDA ITEMS ONLY

Dr. Wargo read Guidelines for Board Policy #0167.3 - Public Participation at Board Meetings and announced that each patron will be allowed to speak for 3 minutes and Mr. Parrish will be timing each speaker. A total of 15 minutes for public participation will be allowed per board meeting. The following patrons requested to speak:

- Shannon Prior requested to speak to protest masks.
- Ryan Dulla requested to speak to protest masks and to request that masking to be optional.
- Nicole Vadas requested to speak about masks and contact tracing.
- Toni Smith requested to speak regarding concerns about wearing masks, CO2 levels and vaccines.
- Michelle Mangus requested to speak regarding COVID and masks.

Dr. Wargo announced that the 15-minute public participation time limit had been reached and announced that three additional patrons have requested to speak. Dr. Wargo asked for a motion from the board to extend the time limit for public participation. Mrs. Sgouros made a motion to extend the meeting an extra 15 minutes to hear additional public participation comments; seconded by Mrs. Chavez. Motion carried 4-0.

- Jessica Contreras requested to speak to protest masks.
- Cameron Moengh requested to speak regarding logic, microns and bacteria.
- Kristin Personius requested to speak to protest masks.

4. AGENDA ADJUSTMENT - Addition to Agenda: COVID UPDATE - Dr. Schmidt

Dr. Schmidt stated the reason for the mask mandate was to keep students in school rather than out of school on quarantine. To answer the question as to why we cannot not mask and not quarantine students, the state requires quarantines. Local health departments are tasked with enforcement which include charges of Class B Misdemeanors for not following state COVID control measures. To answer the question about receiving funding for masking students, Dr. Schmidt stated that there is no additional funding for students wearing masks. Funding for students enrolled virtually is 85%. Students enrolled in-person are funded at 100%. ESSER funds are not dependent on masking.
