Mr. Parrish recommended an increase from \$40.00 to \$50.00 for the maximum daily allowance and an increase from \$25.00 to \$30.00 for the maximum single meal reimbursement for food purchases. Mrs. Sgouros made a motion to approve the recommended revisions to the PTSC credit card and reimbursement procedures increasing the reimbursement amounts to \$50.00 for the maximum daily allowances and increasing to \$30.00 for the maximum single meal reimbursement for food purchases as requested by Mr. Parrish; seconded by Mrs. Harlow.
