



Be it ordained/resolved by the **Board of School Trustees** that for the expenses of **PORTER TOWNSHIP SCHOOL CORPORATION** for the year ending December 31, **2026** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. This ordinance/resolution shall be in full force and effect from and after its passage and approval by the **Board of School Trustees**.


