Mr. Parrish and Dr. Schmidt each attended one day and Dr. Schmidt was able to provide testimony. The vote ended in a 7-4 vote. A Superintendent's Advisory Group has been formed and Dr. Schmidt has been asked to serve on it. The first meeting will be held on January 8 or 9th.
